LIQUID TOURS PTY LTD WILL MAKE EVERY EFFORT TO KEEP YOU INFORMED OF ANY CHANGES, BUT CANNOT BE HELD LIABLE FOR ANY ALTERATIONS MADE TO THE ITINERARIES. Cancellation by the traveller

Booking amendments

TRANSFER FROM ONE TOUR TO ANOTHER:

AMENDMENT REQUEST RECEIVED BY LIQUID TOURS PTY LTD 60 DAYS OR MORE PRIOR TO YOUR ORIGINAL TOUR DEPARTURE DATE - AUD\$125 PER PERSON PER CHANGE PLUS ANY AIRLINE CHARGES. A TRANSFER CAN ONLY BE MADE TO A DEPARTURE DATE WITHIN THE CURRENT VALIDITY. AMENDMENT REQUEST RECEIVED BY LIQUID TOURS PTY LTD LESS THAN 60 DAYS PRIOR TO YOUR ORIGINAL TOUR DEPARTURE DATE - CHARGES AS PER CANCELLATION FEES.

Insurance

WE ALSO RECOMMEND IT COVERS CANCELLATION, CURTAILMENT AND LOSS OF LUGGAGE AND PERSONAL EFFECTS. WE STRONGLY RECOMMEND THAT YOU TAKE OUT TRAVEL INSURANCE AT THE TIME OF BOOKING.

Passports and visas
